Home Ownership for people with Long-term Disabilities (HOLD)

HOLD is a Government approved shared ownership model designed to enable people with disabilities to part buy a home of their own and MySafeHome can help them to do this, even if they can't work due to their disability. HOLD is based on an interest-only mortgage (paid by Support for Mortgage Interest) payable on the buyer's share of the property with the capital being repaid once the property is sold. The remaining share is owned by a housing association that charges rent

(covered by housing benefit) on it.

A deposit for the property will be required (usually about 10% of the property value) which is usually between £15,000 and £20,000. To qualify for HOLD a number of criteria must be filled e.g. the buyer must be aged 18+, in receipt of a care package and certain benefits and unable to work in conventional employment. MySafeHome has helped almost 1,400 people living with disabilities to realise their



dream of home ownership, some of those receive direct payment support from Penderels Trust. As well as the obvious benefits of living in a home of your choice, with the security that brings, many people have reduced their care needs and the costs of care too.

Change to PA Terms and Conditions Timescales

From 1st April 2020, the law is changing and new employees must receive their Terms and Conditions of Employment on the first day of their employment and not within the first 8 weeks as it currently is.

If you would like your independent living adviser to help you to produce Terms and Conditions for a new member of staff, you must give us at least one week's notice so we can get them to you in time.

Auto Enrolment Invoices for Payroll Customers

Our auto enrolment into a workplace pension scheme is an integral part of our payroll service. This scheme is charged for separately and the rates depend on the eligibility of your employees and the payroll service you receive. The auto enrolment service is invoiced annually in arrears. This means that the invoice you will receive in April/May 2020 will be for the year April 2019 to March 2020.
